



Today, December 25 is a very special day for all of us. Our nation marks 100th Jayanti of our beloved former Prime Minister Atal Bihari Vajpayee. He stands tall as a statesman who continues to inspire countless

Our nation will always be grateful to Atal Ji for being the architect of India's transition into the 21st century. When he took oath as PM in 1998 our nation had passed through a period of political instability. In about 9 years we had seen 4 Lok Sabha elections. Coming from humble roots, he realised the struggles of the masses and the transformative power of effective gover-

### Centre's air quality panel revokes curbs under GRAP Stage IV in Delhi-NCR

**NEW DELHI, Dec 24:** The Centre's panel on Delhi-NCR's air quality on Tuesday revoked Stage IV curbs under the Graded Response Action Plan amid a dip in pollution levels, according to an official order.

Delhi's air pollution levels showed a declining trend on Tuesday and the 24-hour average Air Quality Index (AQI) stood at 369 at 4 pm.

According to forecasts from the India Meteorological Department and the Indian Institute of Tropical Meteorology, the air quality situation is predicted to improve further, owing to favourable meteorological conditions.

Stage IV curbs under the Graded Response Action Plan (GRAP) include a ban on all construction activities, entry of non-essential polluting trucks into Delhi, and mandatory shifting of school classes, except for classes 10 and 12, to hybrid mode. (Agency)

From P.1... they give bribe and shut down cases," a local SK Hanan alleged,.

"Not even one single brick-kiln owner has proper documents or permission from the Govt. Almost everyone is doing it illegally. Authorities just take royalty and sit idle when we lodge any complaint." another local Harish Kumar

Huge fine of Rs 1.30 crore was collected from operators in Remuna tehsil due to unlawful stockpiling of materials during 2023-2024 fiscal, as per report. However, the ongoing illegal extraction from Govt and riverine land continues unabated without any intervention.

Residents, caught in a haze of dust and pollutants from these operations, are hapless as any attempts to voice opposition is stifled by the looming menace of the mafias.

When contacted, Dahapada sarpanch Pranati Jena said, "More than 15-20 illegal brick kilns are operating in our panchayat. They are not adhering to any Govt guidelines. I'm sure there is political pressure on authorities who do not take any timely action.

"We have written a letter to State Pollution Control Board here to give information on how many brick-kilns have been given environmental clearance. We will take action accordingly. Our first priority will be to take action against those who are operating brick-kilns by encroaching Govt lands. We will send a notice first to all illegal brick-kiln owners. Strict action will be taken if they do not comply with the notice," Balasore sub-collector Prathamesh Arvind Rajeshirke informed.(OTV)

And what happened? India stood firm and resolute with the Govt calling for another set of tests two days later on May 13! If the tests of the 11th showed scientific skill, the ones on 13 showed true leadership. It was a message to the world that gone was the days when India would buckle under threats or pressure. Despite facing international sanctions, the then NDA Govt of Vajpayee Ji stood firm, articulating India's right to safeguard its sovereignty while simultaneously being the strongest proponent of world peace.

Atal Ji understood Indian democracy and also the need to make it stronger. He presided over the creation of the NDA, which redefined coalitions in Indian politics. He brought people together and made NDA a force for development, national progress and regional ambitions. His parliamentary brilliance was seen throughout his political journey. He belonged to a party with a handful of MPs but his words were enough to rattle the might of the then all-powerful Congress Party. As PM, he blunted the criticisms of the Opposition with style and substance. His had a career spent largely in Opposition benches but never carried any trace of bitterness against anyone, even though the Congress stooped to new lows by going to the extent of calling him a traitor!

He was also not one to cling on to power through opportunistic means. He preferred to resign in 1996 instead of following the path of horse-trading and dirty politics. In 1999, his Govt was defeated by one vote. A lot of people told him to challenge the immoral politics happening then, but he preferred to go by the rules. Eventually, he came back with another resounding mandate from the people.

When it comes to commitment to protecting our Constitution too, Atal Ji stands tall. He was deeply impacted by the martyrdom of Dr. Syama Prasad Mookerjee. Years later, he was a pillar of anti-Emergency movement. In the run-up to 1977 elections after the Emergency, he agreed to merger of his own Party (Jan Sangh) with Janata Party. I am sure it would have been a painful decision but for him, and the others, but safeguarding the Constitution was all that mattered.

It is also noteworthy how deeply rooted Atal Ji was in Indian culture. Upon becoming India's External Affairs Minister, he became the first Indian leader to speak in Hindi at the United Nations. This one gesture showcased his immense pride in India's heritage and identity, leaving an indelible mark on the global stage.

Atal Ji's persona was magnetic and his life was enriched by his love for literature and expression. A prolific writer and poet, he used words to inspire, provoke thought and even offer solace. His poetry, often reflective of his inner struggles and hopes for the nation, continues to resonate with people across age groups.

For so many Bharatiya Janata Party workers like me, it is our privilege that we were able to learn and interact with a person like Atal Ji. His contribution to the BJP was foundational. In those days to spearhead an alternative narrative to the dominant Congress showed his greatness. Alongside stalwarts like L.K. Advani Ji and Dr. Murli Manohar Joshi Ji, he nurtured the party from its formative years, guiding it through challenges, setbacks and triumphs. Whenever the choice came between ideology and power, he always chose the former. He was able to convince the nation that an alternative world view from the Congress was possible and such a world view could deliver.

On his 100th Jayanti, let us rededicate ourselves to realising his ideals and fulfilling his vision for India. Let us strive to build an India that embodies his principles of good governance, unity, and progress. Atal Ji's unwavering belief in the potential of our nation continues to inspire us to aim higher and work harder.

# From diversity to unity: **Manipur Police recruits** ready to serve together

DERGAON (Assam), Dec 24: From breaking bread together to sharing light moments after a hard day in the field, 2,000-odd newly recruited Manipur Police per-

sonnel from various communities mingled freely and made good memories during their year-long rigorous training in Assam.

They will now return to their ethnic trouble-hit state with the message of peace

A total of 1,946 recruits of Manipur Police from Meitei, Kuki, Naga, Muslim and other communities graduated from the Lachit Borphukan Police Academy here on Monday, strengthening the force in the violence-hit northeast-

The newly inducted personnel from different communities said in one voice that they undertook training like brothers since January this year and are now ready to serve Manipur together to spread the message of peace and love among the warring groups.

"We underwent training together here. The cadets comprised all communities living in Manipur including Meiteis, Kukis, Nagas, Muslims, Gorkhas and others," said S Premananda, a personnel from the Meitei community.

During their stay at the Assam Police academy here, the cadets underwent intense physical training together.

"At times, we used to get disturbing news from our parents and relatives. Once we return home, we will try to solve the problems together. We are all ready to do our duties and stay together in Manipur," Premananda said.

The young policeman said that the trainees used to discuss the problems faced by people back home.

"This ongoing ethnic conflict should be over as soon as possible," he added.

Another Meitei cadet, Chirom Shekhariit Singh. said the men in uniform ate, slept and bathed together, and there has been absolutely no hatred towards the fellow Kuki recruits, and the Meitei cadets also never faced any issue from them.

"There was absolutely no problem among the different communities during training here. There was no reflection of the problems back home on us during the training," he added.

Asked if he will serve with Kuki personnel once they return home from Assam, Singh said he does not know where he would be posted but he is ready to serve wherever the government sends him.

'We are ready to serve our state together," he

stressed. Echoing similar sentiments, a Kuki personnel from India Reserve Battalion, P Kipgen, said that recruits from all the communities have undergone training together and they will serve together once they return to Manipur.

"I am a Kuki from Kangpokpi district. We have undergone training with Meitei recruits and we had no issue at all. We had our drills together, had meals in the same dining hall and slept in the same barracks. There was no problem. I cannot say why problems are happening in Manipur. I strongly believe there should be peace in our state," he added.

The intensive 44-week basic training course for the Manipur Police recruits commenced at the academy in January. The ethnic distribution of the recruits was diverse with 62 per cent Meiteis, 12 per cent Kukis and the remaining 26 per cent belonging to Naga and other tribes.

Attending the passingout parade, Manipur Chief Minister N Biren Singh said all the newly recruited cadets, including those from Meitei and Kuki communities, will be posted together as a "team" in an attempt to bring back peace.

MM Zulkib Mughal, a Muslim cadet from Manipur, said that these personnel represented the entire state as the batch comprised people from all communities and they underwent training together.

"Here, we stayed as one unit and there was no problem between the Meitei and Kuki recruits. There was not even one fight between them. The situation in Manipur is also improving," he added.

Mughal expressed optimism that he along with his comrades in Manipur Police will try their best to help improve the situation fur-

"We don't need such fights in our state. We should stay together and peace should return as soon as possible. The state's development will be halted if such clashes go on," he emphasised.

#### **RBI** paper reiterates growth optimism, says economy on recovery path

MUMBAI, Dec 24: After the surprise slump in the second quarter, when GDP growth fell to a sevenquarter low of 5.4 per cent, the economy has regained momentum. According to the Reserve Bank's inhouse researchers and economists, the economy is recovering quickly, driven by strong festival demand and a sustained upswing in rural demand.

The central bank underlined its optimism in the economy's strength in its monthly bulletin.

Following the unexpected slump in the September quarter, the RBI revised down its growth forecast to 6.6 per cent, down 60 bps from the October projection. It has also increased the forecast for average annual inflation for the current fiscal to 4.8 per cent from 4.5 per

In an article on the State of the Economy' in the December bulletin, the analyst noted that the global economy continues to exhibit resilience with steady growth and moderating inflation.

"High-frequency indicators for the third quarter indicate that the economy is recovering from the slowdown in momentum seen in the second quarter, driven by strong festival activity and a sustained upswing in rural demand," they said in the article released Tuesday.

"Our growth trajectory is poised to lift in the second half, driven mainly by resilient domestic private consumption demand. Supported by record-level foodgrains production, rural demand, in particular, is gaining momentum," said the article, authored by a team led by Deputy Governor Michael Debabrata

The prospects for agriculture and, thus, rural consumption are looking up with the brisk expansion of rabi sowing, said

The RBI said the views expressed in the bulletin are those of the authors and do not represent the views of the central bank.

The paper attributed the Q2 growth deceleration to subdued industrial activity at 2.1 per cent versus 13.6 per cent in the corresponding quarter, noting the services sector has exhibited resilience, and so did agriculture, with agri, forestry, and fishing improving to 3.5 per cent in Q2 from 1.7 per cent a year ago. Also, there is an increase in kharif production, supported by abovenormal Southwest monsoons.

Sustained government spending on infrastructure is expected to further stimulate economic activity and investment. Global headwinds, however, pose risks to the evolving outlook for growth and infla-

Expectations around our resilient growth trajectory going forward are also coalescing with more sustainable underpinnings in view of positive climate action, with an increased policy focus on renewable energy, electric vehicles, green hydrogen, and steps towards institutionalising the carbon market.

These concerted efforts indicate a promising path toward achieving net-zero emissions, the paper concludes.

Sounding optimistic about inflation, the article noted that headline consumer price inflation moderated to 5.5 per cent in November on the back of easing food prices from 6.21 per cent in October. (Agency)

# Eleven arrested for alleged involvement in illegal immigration of Bangladeshis racket

NEW DELHI, Dec 24: With the arrest of 11 people, Delhi Police on Tuesday claimed to have unearthed a gang involved in illegal immigration of Bangladeshi nationals.

Among those arrested, four are Bangladeshi citizens and the rest were allegedly involved in making forged documents, an offi-

The gang was busted when our team tracked down four people involved in a murder case in Sangam Vihar on October 21," said Deputy Commissioner of Police (South) Ankit Chauhan.

The Bangladeshi nationals - Midul Miyan alias Akash Ahmed and Fardeen Ahmed alias Abhi Ahmed along with their wives were arrested and interrogated in connection with the murder of Sentu Seikh

"During interrogation, the accused revealed that Sentu, who lived in their neighbourhood, used to bully them over minor issues. Further investigations showed that the accused had entered India illegally and had been resid-

They were found in possession of Bangladeshi ID cards (chip-based NID cards) and birth certificates. Around 21 Aadhar cards, four voter ID cards, and eight PAN cards were also recovered from the victim's residence.

A team led by Inspectors Umesh Yadav and Umesh Sharma, under the supervision of ACPs Abhinendera Jain and Niraj Tokas, was formed to conduct a thorough probe into the illegal immigration issue, Chauhan said.

Further questioning of the accused led to the arrest of Sahil Sehgal, 26, who ran a "Poonam Online Computer Centre" in Rohini Sector 5. It was found that the centre was involved in preparing Aadhaar cards and other documents using fake IDs. Sehgal revealed that he was approached by illegal Bangladeshi immigrants through the deceased Sentu Seikh alias Raja, according to the police.

"Sahil used the fake website 'Jantaprints.site' to generate fraudulent birth

several years," the officer to his associate Ranjit for Aadhaar card processing," the officer said.

Ranjit, a resident of Sector 7 in Rohini, worked with Afroz, 25, an authorised Aadhaar operator at Karnataka Bank in Rohini Sector 5. Using fake birth certificates, Afroz facilitated the creation of Aadhaar cards.

Ranjit and Afroz were arrested, and investigations revealed that "Jantaprints.site" offered fake documents, including birth certificates, matriculation certificates, caste certificates, COVID certificates, and income certificates, at nominal prices starting from Rs 7, the of-

ficer said. Payments for these documents were made via Paytm QR codes linked to a number registered under Mohammad Chand. Based on technical surveillance, Mohammad Chand, 28, from Uttam Nagar, was arrested from Vikas Nagar, Delhi. He confessed to retaining a 2 per cent commission and transferring the remaining amount to Saddam Hussain.

Saddam Hussain, 33, certificates and sent them from Uttam Nagar, was arrested, leading to the disthat "Jantaprints.site" was operated by his associate, Deepak Mishra. Saddam transferred the payments to Deepak Mishra, retaining a 2 per cent share for himself.

Further questioning revealed that the accused initially created Aadhaar cards showing ages under 18, as such cards were easier to process at multiple centres in Delhi. Cards for individuals over 18 were limited to just four centres

Technical surveillance led to Deepak Mishra, 34, from Uttam Nagar, being apprehended in Ambala and arrested after sustained interrogation. He disclosed that his brother-in-law, Sonu Kumar, developed the "Jantaprints.site."

Sonu Kumar, 31, was arrested from Noida, where he admitted to learning how to create fake websites via YouTube. He also created "Portalwale.com" and "Portalwale.online" for creating fake ID documents.

Sonu Kumar runs a cyber café in Noida, the police said, adding that further investigations are on.

# 5 soldiers killed, 5 injured as Army vehicle plunges into 300-foot gorge in Kashmir; terror angle ruled out

JAMMU, Dec 24: Five soldiers died and five others sustained injuries after an Army vehicle veered off the road and fell into a gorge in the Balnoi area of Mendhar, Poonch district, Jammu and Kashmir, on Tuesday, officials said.

A defence spokesperson ruled out any terror angle, stating that the cause of the accident is under investigation. He suggested that "possibly the driver lost control at the turn of the road". The vehicle reportedly

plunged into a gorge, approximately 300-350 feet According to reports,

police officials have stated that the accident occurred at around 5:40 pm when an Army vehicle of the 11 Maratha Light Infantry, travelling from Nilam headquarters to Balnoi Ghora Post along the LoC, fell into a gorge near Ghora Post.

Officials said that the injured have been shifted to a military hospital for treatment, adding one of them is in critical condition.

Upon receiving the information, the Quick Reaction Team of 11 MLI swiftly arrived at the site to carry out rescue operations. The injured personnel were given immediate medical attention, and efforts are ongoing to evacuate them for further

# Harleen's maiden ton leads India to ODI series win over West Indies

Indian women's team secured the three-match ODI series against the West Indies with a dominant 115run victory in the second game at Vadodara.

India's batters were in roaring form, posting their joint-highest total in ODIs. Harleen Deol smashed her maiden century, supported by fifties from Smriti Mandhana, Pratika Rawal and Jemimah Rodrigues. Despite Hayley Matthews brilliant century for West Indies, the visitors fell well short, losing with 3.4 overs

Harmanpreet Kaur won the toss and chose to bat, fielding an unchanged XI from the previous game. The opening pair of Smriti and Pratika once again gave India a solid start with a stand of 110 runs. Smriti was dismissed after scoring 53 off 47 balls, following a mix-up that resulted in an unfortunate run-out. Pratika tried to sacrifice her wicket for her senior partner but was caught short. Harleen joined Pratika at the crease, and the duo added 62 for the second

IŤANAGAR, Dec 24: The Women's Football Federation of India (WFFI) has received proposals from Bihar, Madhya Pradesh, Jammu & Kashmir, Punjab and Uttar Pradesh for conducting National Women Football Championship, said its president Mukesh Sharma on Tuesday.

The WFFI observer team would be visiting these states soon to inspect existing stadiums, available fooding and lodging facilities for the players and submit its report to the central committee about which state fulfills the terms and conditions to take a final decision on which state would be entrusted the responsibility to conduct the national event.

"I am hopeful to conduct the tournament in January next for the WFFI actions to be visible soon that too with the involvement of na-



tional and international sports medal winners, top ranking corporate honchos and dignitaries,' he said with conviction.

The process of appointment of members of 16 committees of the WFFI would be completed soon while coordination committee chairman Rajesh Singh Rajput is on his toes for making the first steps successful, he said.

The central selection committee would select players in a very transpar-

ent manner based on talent only as the team would represent the nation in international events, he said while hinting at his plan for Asian Championship which could be conducted in Goa.

There are many such national and international championships in the pipeline which would be conducted in due time, said Sharma, a great disciple of National Youth Project founder late Dr S N Subba Rao, and was associated in many National Youth Integration camps in the past.

# Hero MotoSports names Cornejo as new rider reveals 3-member side for Dakar

NEW DELHI, Dec 24: Hero MotoSports Team Rally on Tuesday named young Chilean rider Nacho Cornejo as its new recruit while announcing a threemember team for the Dakar Rally 2025.

Cornejo will team up with Sebastian Buhler and 2024 FIM World Rally-Raid Championship (W2RC) winner Ross Branch. This will be the team's

ninth appearance in the world's toughest race, scheduled to take place in Saudi Arabia from January 3 to 17.

It was memorable 2024 for the young team as it secured an overall second fin-

In the 12-stage 2024 edition, Branch led the race for four days and remained at second spot for eight days, eventually finishing second overall, making Hero MotoCorp the first Indian it to the Dakar podium.

For Botswana's Branch, this will be his third Dakar outing with the team. Buhler, a German living

in Portugal, has given consistent performances this year, marking his biggest achievement by securing his first FIM World Championship race podium at Rally Raid Portugal, where he finished second overall.

At the 2024 Dakar Rally, Buhler came close to winning his first Dakar stage.

Young Chilean rider Cornejo boasts of an impressive Dakar record, including a fourth-place finish in 2020 and nine stage

The 47th Dakar Rally will kick off in Bisha, featuring a prologue and 12 stages spanning 7,700 km across the vast desert. For the first time, five stages will have separate courses for FIM manufacturer team to make and FIA vehicles, covering 45 per cent of the timed dis-

Dakar 2025 will also be the opening race of the fourth edition of the World Rally Championship (W2RC).

Hero MotoSports is a Rally GP-class participant at the W2RC 2025, and will attend its five rounds starting with the Dakar, followed by the Abu Dhabi Desert Challenge (February), South African Safari Rally (May), BP Ultimate Rally Raid in Portugal (September), and finally closing the season with the Rallye du

# India name 15-member squad for ICC Under-19 Women's T20

NEW DELHI, Dec 24: India on Tuesday named a 15-member squad for next year's ICC Under-19 Women's T20 World Cup to be played in Kuala Lumpur, Malaysia from

January 18 to February 2. The Women's Selection Committee of the BCCI announced the squad to be led by Niki Prasad, while Sanika

Chalke will be the vicecaptain.

The squad has two wicketkeepers Kamalini G and Bhavika Ahire, while three

players, standby Nandhana S, Ira J and Anadi T, have also been included.

The 16 competing teams have been divided into four groups.

India are the defending champions, and are placed in Group A alongside hosts Malaysia, West Indies and Sri

Lanka. The tournament will be hosted by Bayuemas

India will begin their campaign against West Indies on January 19, followed by matches

against Malaysia (January 21) and Sri Lanka (January 23).

Following the group phase, which runs from January 19-23, the top three teams from each group will advance to the Super 6 stage -- two groups of six --, which will take place from January 25-29.

Group 1 in Super 6 will

include the top three ent position. teams each from Group A and D, while Group 2 will have the top three teams each from Group B and C.

The teams will carry forward their points and net run rates (NRR) from the initial group phase and will play the two sides who were not in their original group and South Africa, Sri Lanka, who finished at a differ-

The top two sides from the two Super 6 stage groups will qualify for the semifinals, slated for January 31 while the final will be played on February 2.

Australia, Bangladesh, England, India, Ireland, New Zealand, Pakistan, and the West Indies

have qualified through their participation in the 2023 edition, while Malaysia earned automatic qualification as hosts.

Nepal, Nigeria, Samoa, Scotland and the United States have earned their spots through the various regional qualification tournaments.
